

# Riverwalk Athletic Club Minor Release & Pool Waiver

*(Please fill out for anyone in attendance who is UNDER 18 years of age)*

The **Swimming Facility** at the **Riverwalk Athletic Club** does not have a lifeguard. Swim at your own risk.

We are required to notify you of these rules, to ensure that water rescue equipment is at the pool and that the swimming area is maintained in a sanitary manner. In the interest of your safety and that of your guests, we require you to follow these rules.

Please read the safety rules located at the pool and outlined in this brochure. If you have any questions, we will be happy to discuss them with you.

Your safety is important to us. After you have read this waiver, please sign the bottom section. Only minors who have a parent/guardian read and sign this waiver on their behalf may use the pool and bathing area.

- **Never swim alone.** A minimum of 2 adults, 18 years of age or older must be present whenever this swimming facility is in use, with at least one adult on the pool deck.
- **Use of the pool by hotel guests is limited solely to registered hotel guests.**
- **There is no substitute for adequate supervision.** Children under 18 years of age must be accompanied to the pool area by a parent or guardian, or an adult who is responsible for the children and their behavior.
- **In an emergency, notify the facility operator and contact help immediately.** A free telephone is provided in the pool area. Telephone numbers for the nearest emergency medical service are posted.
- **Only use this facility during posted hours of operation. Same as club hours.**
- **Don't drink alcohol and swim.** Injuries can be prevented and safety is everyone's responsibility. If you notice any problems with the water quality or the absence of safety equipment, please notify us at once.
- **No running or diving in the pool area.**
- **Failure to comply will result in eviction from the pool.**

I, the minor's parent and/or legal guardian, understand that exercise can be strenuous and subject to risk of serious injury and believe the minor to be qualified, in good health, and in proper physical condition to participate in such activity. I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless the Club and all affiliates, employees, agents, representatives, sub-contractors successors, or assigns from all liability claims, demands, losses, or damages on the minor's account caused or alleged to be caused in whole or in part by the negligence of the Club' or its affiliates, employees, agents, representatives, sub-contractors successors, or assigns or otherwise, including negligent rescue operation and further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the Club, or any affiliates, employees, agents, representatives, sub-contractors successors, or assigns I will defend, indemnity, save, and hold harmless the Club and all affiliates, employees, agents, representatives, sub-contractors successors, or assigns from any litigation expenses, attorney fees, loss liability, damage, or cost any may incur as the result of any such claim.

**I have read and understand the bathing safety rules at this facility. I understand there will not always be a lifeguard on duty at this facility. I ensure the minor I am signing for will abide by the rules listed in this brochure.**
